Privacy Policy

1. <u>Introduction</u>

McU Sports, Inc. ("McU", "we", "our", or "us"), respects your privacy and is committed to protecting it through compliance with this policy.

This policy (as amended from time to time, this "**Privacy Policy**") describes the types of information we may collect from you or that you may provide when you visit the website <u>mcusports.com</u> including all related McU websites, desktop and mobile applications and other services provided by McU (collectively the "**Website**"), and our practices for collecting, using, maintaining, protecting, and disclosing that information.

We use information you provide in connection with providing and improving the Website and taking certain actions on your behalf and as authorized by you. By using the Website, you agree to the collection and use of information in accordance with this Privacy Policy.

2. <u>Information Collection and Use</u>

While using the Website, we may ask you to provide us with certain information, including without limitation personally identifiable information that can be used to contact or identify you. This Privacy Policy applies to information we collect:

- on our Website;
- in email, text, and other electronic messages between you and our Website;
- through our mobile and desktop applications, which provide a dedicated nonbrowser-based interaction between you and our Website; and
- when you interact with our advertising and applications on third-party websites and services, if those applications or advertising include links to this Privacy Policy.

This Privacy Policy does not apply to information collected by:

- us offline or through any other means, including on any other website operated by us or any third party that does not include a link to this Privacy Policy; or
- any third party, including through any application or content (including advertising) that may link to or be accessible from or on the Website.

Please read this Privacy Policy carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, you must not use our Website. By accessing or using our Website, you agree to this Privacy Policy. This Privacy Policy may change from time to time (see provisions set forth under the heading *Changes to Our Privacy Policy*). Your continued use of our Website after we make changes is deemed to be acceptance of those changes, so please check this Privacy Policy periodically for updates.

3. <u>Children's Privacy</u>

Our products, services and Website are not intended for children under 13 years of age. No one under the age of 13 may provide any information to us or on the Website. We do not knowingly collect, solicit or allow such persons provide such information to us or to register for an account with us. If you are under 13 years of age, do not use or provide any information on our Website or on or through any of its features, register on the Website, make any purchases through the Website, use any interactive or public comment features of our Website or provide any information about yourself to us, including your name, address, telephone number, email address, or any screen name or user name you may use. If we learn we have collected or received personal information from a child under 13 without verification of parental consent, we will delete such information and/or account. If you believe we might have any information from or about a child under 13, please contact us pursuant to one of the means listed under the heading *Contact Information*.

4. Information We Collect About You and How We Collect It

We collect several types of information from and about users of our Website, including, (but not limited to) information:

- by which you may be personally identified, including without limitation: name, postal address, e-mail address, telephone number, driver's license number and state of issuance, other information you may voluntarily provide and any other identifier by which you may be contacted online or offline ("**personal information**");
- related to payment transactions, including without limitation credit card details;
- that is about you but individually does not personally identify you, such as your birthdate; and/or
- about your internet connection, the equipment you use to access our Website and usage details.

We collect this information:

- directly from you when you provide it to us;
- automatically as you navigate through the Website (information collected automatically may include usage details, IP addresses, and information collected through cookies and other tracking technologies); and/or
- from third parties, for example, our business partners.

4.1 Information You Provide to Us

The information we collect on or through our Website may include:

- Information that you provide by filling in forms on our Website. This includes, without limitation, information provided in connection with:
 - o Account Profiles: When creating account profiles, including a designated username, you may provide information, including personal information.
 - o Contests, Sweepstakes and Other Promotions: We may ask you for information when you enter a contest, sweepstake or other promotion sponsored by us.
- Records and copies of your correspondence (including email addresses), if you contact us, including without limitation to report any problem with the Website.
- Your responses to surveys that we might ask you to complete for research purposes.
- Details of transactions you carry out through the Website or otherwise regarding the fulfillment of any orders initiated through the Website. You may be required to provide financial information before placing an order through the Website.
- Your search queries on the Website.

You also may provide information, documents or other content to be published or displayed (hereinafter, "**posted**") on public areas of the Website, or transmitted to other users of the Website or third parties (collectively, "**User Contributions**"). Your User Contributions are posted on and transmitted to others at your own risk. <u>Although we limit access to certain pages, please be aware that no security measures are perfect or impenetrable.</u> Additionally, we cannot control the actions of other users of the Website with whom you may choose to share your User Contributions. Therefore, we cannot and do not guarantee that your User Contributions will not be viewed by unauthorized persons. Other users may share your User Contributions, as necessary or advisable, to maintain, provide and improve services; resolve support requests; delete posts; and comply with applicable laws and regulations.

User Contributions may involve uploading, inputting and posting various content to be displayed to other users. Through the Website's interactive features, to the extent applicable, you may choose to submit and post questions, comments, or other content. Certain information such as your username, name and profile information may be publicly displayed on any posted content.

You acknowledge and agree that you have no expectation of privacy to any personal information that you disclose in anything that you post or link to your profile.

4.2 Information We Collect Through Automatic Data Collection Technologies

As you navigate through and interact with our Website, we may use automatic data collection technologies to collect certain information about your equipment, browsing actions, and patterns, including:

- Details of your visits to our Website, including traffic data, location data, logs, and other communication data and the resources that you access and use on the Website.
- Information about your computer and internet connection, including your IP address, operating system, and browser type.

We also may use these technologies to collect information about your online activities over time and across third-party websites or other online services (behavioral tracking).

The information we collect automatically is statistical data and may include personal information, or we may maintain it or associate it with personal information we collect in other ways or receive from third parties. Collecting such data helps us to improve our Website and to deliver a better and more personalized service, including by enabling us to:

- Estimate our audience size and usage patterns.
- Store information about your preferences, allowing us to customize our Website according to your individual interests.
- Speed up your searches.
- Recognize you when you return to our Website.

The technologies we use for this automatic data collection may include:

• **Cookies (or browser cookies).** We use cookies to, among other things, save your preferences for future visits, keep track of advertisements and compile aggregate data about site traffic and site interactions to help us offer better site experiences in the future. A cookie is a small file placed on the hard drive of your computer. You may refuse to accept

browser cookies by activating the appropriate setting on your browser. However, if you select this setting you may be unable to access certain parts of our Website. Unless you have adjusted your browser setting so that it will refuse cookies, our system will issue cookies when you direct your browser to our Website.

- Flash Cookies. Certain features of our Website may use local stored objects (or Flash cookies) to collect and store information about your preferences and navigation to, from, and on our Website. Flash cookies are not managed by the same browser settings as are used for browser cookies. For information about managing your privacy and security settings for Flash cookies, see the provisions contained under the heading *Choices About How We Use and Disclose Your Information*.
- Web Beacons. Pages of our Website and our e-mails may contain small electronic files known as web beacons (also referred to as clear gifs, pixel tags, and single-pixel gifs) that permit the Company, for example, to count users who have visited those pages or opened an email and for other related website statistics (for example, recording the popularity of certain website content and verifying system and server integrity).

We do not collect personal information automatically, but we may tie this information to personal information about you that we collect from other sources or that you provide to us.

5. <u>Third-Party Use of Cookies and Other Tracking Technologies</u>

Some content or applications, including advertisements, on the Website are served by third-parties, including advertisers, ad networks and servers, content providers, and application providers. These third parties may use cookies alone or in conjunction with web beacons or other tracking technologies to collect information about you when you use our Website. The information they collect may be associated with your personal information or they may collect information, including personal information, about your online activities over time and across different websites and other online services. They may use this information to provide you with interest-based (behavioral) advertising or other targeted content.

We do not control these third parties' tracking technologies or how they may be used. If you have any questions about an advertisement or other targeted content, you should contact the responsible provider directly. For information about how you can opt out of receiving targeted advertising from many providers, see the provisions contained under the heading *Choices About How We Use and Disclose Your Information*.

6. <u>How We Use Your Information</u>

We use information that we collect about you or that you provide to us, including any personal information:

- To present our Website and its contents to you, including without limitation through a customized experience.
- To provide you with technical support and responses to submitted enquiries.
- To operate and maintain your account, if any, and provide you notices about such account.
- To identify you as the author and content creator of any digital media you upload or post, comments, and other User Contributions that you make on the Website.
- To provide and display your posted content to other users of the Website.
- To prevent or take action against activities that are, or may be, in breach of our Terms of Use or applicable law.
- To provide you with information, products, or services that you request from us.
- To provide you with information regarding any contests, sweepstakes or other promotions that may be offered by us from time to time.
- To provide you with notices about your account.
- To fulfill any other purpose for which you provide it.
- For product purchases, your personal and payment information will be used to process your purchases and/or renewals and to collect payment.
- To carry out our obligations and enforce our rights arising from any contracts and/or authorized transactions entered into between you and us, including for billing and collection and including the disclosure of applicable billing information to any third party payment processing company.
- To notify you about changes to our Website or any products or services we offer or provide through it.
- To allow you to participate in interactive features on our Website.
- To conduct research and development for the improvement of our Website, services and other products.
- In any other way we may describe when you provide the information.

• For any other purpose with your consent.

We may also use your information to contact you about our own and third-parties' goods and services that may be of interest to you. If you do not want us to use your information in this way, please see the provisions contained under the heading *Choices About How We Use and Disclose Your Information*.

We may use the information we have collected from you to enable us to display advertisements to our advertisers' target audiences. Even though we do not disclose your personal information for these purposes without your consent, if you click on or otherwise interact with an advertisement, the advertiser may assume that you meet its target criteria.

7. <u>Disclosure of Your Information</u>

We may disclose aggregated information about our users, and information that does not identify any individual, without restriction.

We may disclose personal information that we collect or you provide as described in this Privacy Policy:

- To our subsidiaries and affiliates.
- To contractors, service providers, and other third parties we use to support our business. This may include without limitation: maintenance services, database management, payment processing, fraud detection, web analytics, and online advertising.
- To a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, equity sale or sale or transfer of some or all of our assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information held by the Company about our Website users is among the assets transferred or will otherwise be under the control of such buyer or successor following the consummation of such transaction.
- To third parties to market their products or services to you if you have not opted out of these disclosures. For more information, see the provisions contained under the heading *Choices About How We Use and Disclose Your Information.*
- For any other purpose disclosed by us when you provide the information.
- With your consent.
- To comply with any court order, law, or legal process, including making available winner's lists with respect to any contest, sweepstakes or other promotion, or responding to any

government or regulatory request, any subpoena, or any other governmental investigation, or in cooperation with any government agency, official or other authorized representative.

- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of the Company, our customers, or others.
- To protect our interests. Your information will be disclosed if we feel it is necessary in order to protect or defend our legitimate interests and rights, or those of our users, employees, directors, managers, officers, or equity holders, and/or to ensure the safety and security of McU and/or the McU user community.

McU actively works to prevent unauthorized persons from accessing our files or hacking into our Website. We cannot guarantee these efforts will always be successful or that your information may not be altered, misused, or lost. We are not responsible for any security breaches or any misuse of your information received by a third party.

8. <u>Choices About How We Use and Disclose Your Information</u>

We strive to provide you with choices regarding the personal information you provide to us. We have created mechanisms to provide you with the following control over your information:

- **Tracking Technologies and Advertising.** You can set your browser to refuse all or some browser cookies, or to alert you when cookies are being sent. To learn how you can manage your Flash cookie settings, visit the Flash player settings page on Adobe's <u>website</u>. If you disable or refuse cookies, please note that some parts of the Website may then be inaccessible or not function properly.
- **Disclosure of Your Information for Third-Party Advertising.** If you do not want us to share your personal information with unaffiliated or non-agent third parties for promotional purposes, you can opt-out by (1) checking the relevant box located on the form on which we collect your data,(2) logging into the Website and adjusting your user preferences in your account profile or (3) sending us an email stating your request to the email address listed under the heading *Contact Information*.
- Promotional Offers and Alerts from the Company. If you do not wish to have your contact information used by the Company to promote our own or third parties' products or services or to provide you scheduled alerts you can opt-out by (1) checking the relevant box located on the form on which we collect your data or (2) logging into the Website and adjusting your user preferences in your account profile or (3) sending us an email stating your request to the email address listed under the heading *Contact Information*. If we have sent you a promotional email or an email containing a scheduled alert, you may click on the 'Unsubscribe' link found at the bottom of such email, if any, and follow the steps

presented to you or send us a return email asking to be omitted from future email distributions.

- **Targeted Advertising.** If you do not want us to use information that we collect or that you provide to us to deliver advertisements according to our advertisers' target-audience preferences, you can opt-out by (1) checking the relevant box located on the form on which we collect your data or (2) logging into the Website and adjusting your user preferences in your account profile or (3) sending us an email stating your request to the email address listed under the heading *Contact Information*. We do not control third parties' collection or use of your information to serve interest-based advertising. However such third parties may provide you with ways to choose not to have your information collected or used for advertising purposes.
- Social Networks and Connected Applications. In the case of some such social networks, any new content media you post will be shared to those networks and will be visible to your followers and friends on those networks. McU is not responsible for other social networks or apps showing your content or information.

9. Accessing and Correcting Your Information or Closing your Account

You can review and change your personal information by logging into the Website and visiting your account settings profile page. You are responsible for maintaining the accuracy of information you submit to us, such as your contact information, and you must update your account information with any changes through your account settings profile page.

You may also send us an email to the email address listed under the heading *Contact Information* to request access to, correct or delete any personal information that you have provided to us. We cannot delete your personal information except by also deleting your user account. We may not accommodate a request to change information if we believe the change would violate any law or legal requirement or cause the information to be incorrect.

If you delete your User Contributions from the Website, copies of your User Contributions and personal information may remain viewable in cached and archived pages, or might have been shared, copied or stored by other Website users. Neither you nor McU can delete all copies of media content or information that has been previously shared with others.

If you delete your account information, your account may become deactivated. If you ask to close your account or it is deactivated, you will no longer to be able to use the Website as a registered user. You may delete your account through your account settings profile page or by contacting us. After deleting your account, certain account history and information may not be attainable, even upon request. However, it may not be possible to completely remove or delete all of your information and User Contributions from our databases, from cached and archived pages or from media content that has been previously shared with others. Additionally, certain information and User Contributions may actively persist in our system's database for administrative purposes even after you close your account.

10. Your California Privacy Rights

California Civil Code Section § 1798.83 permits users of our Website that are California residents to request certain information regarding our disclosure of personal information to third parties for their direct marketing purposes. 11. Data Security

The safety and security of your information also depends on you. To the extent you have a password for access to certain parts of our Website you are responsible for keeping such password confidential. We ask you not to share your password with anyone. We urge you to be careful about giving out information in public areas of the Website. The information you share in public areas may be viewed by other users of the Website.

Unfortunately, the transmission of information via the internet is not completely secure. Although we do our best to protect your personal information, we cannot guarantee the security of your personal information transmitted to our Website. No method of electronic storage or transmission of information over the internet is 100% secure. Any transmission of personal information is at your own risk. We are not responsible for circumvention of any privacy settings or security measures contained on the Website.

12. Changes to Our Privacy Policy

It is our policy to post any changes we make to this Privacy Policy on this page. If we make material changes to how we treat our users' personal information, we may notify you by email to the primary email address specified in your account and/or through a notice on the Website home page. The date this Privacy Policy was last revised is identified at the top of this page. You are responsible for ensuring we have an up-to-date active and deliverable email address for you, and for periodically visiting our Website and this Privacy Policy to check for any changes.
